Dear President and Secretary,

The purpose of this letter is to share some information about PSPL's financial results for the year ended 31 March 2021.

The 2020-21 year presented some significant challenges due to the impact of the COVID-19 pandemic. Everyone in our community, including the PSPL staff, have all been affected in some way, shape or form.

Throughout the year we have continued to focus on the provision of service and support to the Probus Community across Australia and New Zealand with a key focus on assisting our volunteer Management Committees deliver fun, friendship and fellowship in what can only be considered a very strange year.

PSPL achieved an after-tax surplus of \$51,236 against the loss of \$66,570 in the previous year. This result includes significant assistance from the Australian Government's JobKeeper and Cash Flow Boost programs for companies affected adversely by COVID-19.

The table below shows a summary of the financial results for the year ended 31 March 2021 compared to the previous year.

A revised business model in line with reduced levels of revenue was progressively implemented during the 2020-21 year resulting in a lowering of PSPL's cost base. Despite the financial challenges, the important financial health indicators of total funds, working capital and available funding

reserves were all very strong at year end.
